



Challenges






In 2016, there were over 240 million1 cars on the road in America.

With 1.62 cars per household² in Los Angeles, this means more than 2.4 million vehicles in the city area.

Gridlock

A 2017 study showed that Los Angeles drivers spend 102 hours in traffic on average. That's the most time drivers spend in rush-hour traffic anywhere in the world.



Lack of Space

The parking space used by employees in Santa Monica every day is equivalent to 22 Third Street Promenades⁵.

That's over 20 football fields dedicated to parked cars.



Poor Air Quality

64% of Santa Monica's greenhouse gas emissions come from vehicular transportation³.

As well as contributing to climate change, long term exposure to pollutants can present health risks.



Safety


In 2017, there were 55,3506 traffic collisions in Los Angeles, killing 260⁷ road users and pedestrians.


Regional Success Story

Santa Monica believes that streets are for everyone - pedestrians, bicycles, motorists, and transit riders. And the roads and transportation networks are being updated to support this position. The City's investments in mobility are showing results. People traveling in Santa Monica make the sustainable choice far more often than those elsewhere in the LA region.

The TMO Difference

Terms & Abbreviations

AVR

Average Vehicle Ridership is the ratio of people (or employees) to vehicles (cars) at a place of employment

ETC

An Employee Transportation Coordinator is the person responsible for completing and implementing an employer's transportation plan

Sustainable trips

A trip which has a lower impact on the environment, such as walking or cycling as opposed to driving

TDM

Transportation Demand Management is the practice of changing how, when, and where people move around the city by encouraging more efficient types of transportation behavior


TMC


Transportation Management Organization, is an organization which works with companies to encourage sustainable trips The GoSaMo TMO works closely with Santa Monica employers to help them meet their Average Vehicle Ridership (AVR) targets and find the best options for their commuters. The employers the TMO works most closely with have shown the biggest reduction in drive alone trips.



Impact

TMO engaged employers increased the percentage of non-drive alone trips made by their employees from 37% to 40%





Engagement

The number of employers engaged by the TMO nearly tripled this year. Much of it was due to the City of Santa Monica including the TMO's contact information in their notices.

Not only did this lead to more employers contacting the TMO but it also freed the TMO from engaging in active outreach to inform employers of the services on offer and allowed us to assist more employers.
